A. Programme Rationale

The programme is designed to enable Nursing and Midwifery Council (NMC) registered nurses to adopt a strategic approach to the provision of advancing community nursing specialist practice, whilst, where appropriate, effectively collaborating with other disciplines and agencies, to promote the health and well-being of individuals, families, groups, and communities. The programme fulfils the education and professional Standards of Proficiency for Community Nursing Specialist Practice Qualification developed by the Nursing and Midwifery Council (2022). The programme leads to eligibility to apply for a recordable qualification with the Nursing and Midwifery Council and professional recognition as a specialist community nurse as either a community children's nurse, district nurse or general practice nurse. Students undertake Nurse Independent / Supplementary Prescribing (V300) qualification leading to a recordable qualification with the Nursing and Midwifery Council as a specialist community nurse, community children's nurse with integrated independent purse prescriber, specialist community nurse, district nurse with integrated independent Nurse Prescriber specialist community nurse, general practice nurse with or without integrated independent nurse prescriber. Independent nurse prescribing is integrated into the programme and cannot be awarded as a separate final award.

The programme is designed to enable students to achieve the capabilities of advanced practice map to the pillars of advanced practice. The programme is also mapped to the QNI Field Specific Standards for Specialist Community Nursing Qualifications which have been mapped to the four Pillars of Advanced Practice.

B. Educational Aims of the Programme

Diversity and Inclusion

Teaching/learning methods & strategies

Acquisition of knowledge and understanding is through a combination of lectures (A1-A14), seminars and simulated practice learning (A1-A14), and clinical placement (A1-A14) at level 7 in the programme. Throughout, the learner is encouraged to undertake independent study both to supplement and consolidate what is being taught / learnt and to broaden their individual knowledge and understanding of the subject. Learning is then enhanced through discussions with lecturers and expert practitioners in the fields of community and primary care, public health, social work, and research, which are related to specialist community nursing practice throughout the programme

Teaching and learning activities involve both specialist learning with other students in the same intended field of practice shared learning with students undertaking specialist community public health nursing in health visiting and school nursing and advanced clinical practice Throughout all activities the primacy of professional practice is actively supported, and students are facilitated to apply and integrate their theoretical knowledge within their professional practice through small group discussions, tutorials, guided study, and online learning.

All knowledge and understanding will be learnt in the university setting and applied into clinical practice and vice versa. As the learners complete each module, a scaffolding strategy will occur, with the latter modules of the

Assessment

Knowledge and understanding are assessed through a combination of coursework (A1-A4, A14), presentations (both live and narrated) (A5 A7), Poster Presentation (A3, A8) OSCE (A3, A10, A11-13,) and clinical assessment in placement (A1-A14).

Generally, and where it can be accommodated, assessments offer a choice of titles or themes to enable learners to demonstrate knowledge and understanding in relation to their own area of specialist expertise and interest.

Every assessment will be supported by a formative assessment which will reflect wholly, or in part, the summative assessment.

Analysis, problem-solving and decision-making skills (B1-B16) are further developed through lectures, student led seminars and action learning sets, simulated practice learning to develop deeper learning.

Intellectual skills will be further developed when learners are operating within clinical practice placement under the direction of practice supervisor(s) and practice assessor in the form of reflective discussions. These discussions provide an opportunity for the learners to reflect upon a range of practice issues relating to their field of practice. In particular, the clinical placement enables direct experience of a wide variety of professional issues through which skills can be developed (B1-B16).

In addition, group work will be encouraged across as all learning outcomes (B1-B16) in both the university setting and clinical environments through peer observations and commentary, reflecting the approach to required personalised intellectual skills to the sensitive and unique nature of clinical work within community nursing services.

Intellectual skills are assessed through a combination of coursework (B1, B5, B7-B12), presentations (both live and narrated) (B2, B6), OSCE (B3, B7-11,) Poster Presentation (B2) and clinical assessment in practice placement (B1-12). Every assessment will be supported by a formative assessment which will reflect wholly, or in part, the summative assessment.

For B13-B16, assessments will be primarily researchand enquiry-based through ultimate achievement of an independent piece of summative work i.e., a dissertation.

All assessments will ensure equitable opportunities for successful achievement and award of grades through careful design and marking.

D. Programme Structures, Features, Levels, Modules, and Credits

The normal length of the programme is full-time over 52 weeks (one calendar year), and for part-time normally over 2 calendar years leading to an award of a Postgraduate Diploma in Specialist Community Nursing (Community Children's Nursing, District Nursing or General Practice Nursing). The programme of study also leads to annotation on the Nursing and Midwifery Council register as a Specialist Community Nurse as either a Community Children's Nurse, District Nurse or General Practice Nurse. On successful completion of the relevant Postgraduate Diploma (120 credits) students can return to study to top up to a MSc Specialist Community Nursing by successfully completing Integrating Research with Contemporary Practice (7HSK2078 15 credits), Preparation for Research Project (7HSK2049 15 credits) and Research Project (7HSK2048 30 credits).

Shared learning occurs between health visitors, school nurses, community children's nurses, district nurses and general practice nurses, on relevant parts of the programme. Students are enabled to explore and integrate theoretical learning in the context of their specialist area of practice through the teaching and learning methods and strategies as outlined within Section C above. Teaching takes place either face to face or online (hybrid) through lectures, small group work, seminars, practical lab sessions and simulation to enable students to apply and integrate knowledge and intellectual, practical and transferable skills from without and within their intended field of practice.

Professional and Statutory Regulatory Bodies

To be eligible for annotation of their Specialist Community Nursing Qualification on the Nursing and Midwifery Council students must successfully complete the 120 credits relevant to the pathway on which they are enrolled outlined in the tables below.

If a student undertakes the programme where the Nurse and Midwife Independent / Supplementary Prescribing module (V300) is integrated, both specialist community nursing and independent nurse prescribing must be passed, as the students' prescribing practice is integrated into their qualification. One therefore cannot be awarded without the other.

Students must register their Specialist Community Nurse Practice Qualification with the Nursing and Midwifery Council within 5 years of successfully completing the programme and failure to do so will result in a requirement to undertake additional education and training or gain experience as specified in Nursing and Midwifery standards for the award to be registered (NMC 2022).

Work-Based Learning, including Sandwich Programmes

To meet the Nursing and Midwifery Council (2022) Standards of Proficiency for Community Nursing Specialist Practice Qualification all students must undertake a period of practice experience of at least 50% of the 45 weeks (pro rata for the part-time route) of the programme, working under the support a Practice Supervisor and a Practice Assessor. Practice competencies are assessed summatively, by a Practice Assessor in partnership with the Academic Assessor. All Practice Assessors and Practice Supervisors must meet the MMC Standards for Student Supervision and assessment (2018, updated 2023)

The Practice Assessor must hold a Specialist Community Nurse Practice Qualification (SPQ) qualification with the NMC or have appropriate experience in the field of practice of the student they are assessing. The Practice Assessor will have been nominated by the practice placement provider and have been appropriately prepared for the role to meet the Nursing and Midwifery Council Standards for Student Supervision and Assessment (2018, updated 2023) to appropriately assess a student. They must have undertaken a period of preceptorship in line with the NMC principles for preceptorship as an SPQ and / or can evidence prior learning and experience that enables them to engage in fair, reliable and valid assessment prosses in the context of SPQ in the field of practice of the student.

The Practice Supervisor must hold an SPQ qualification with the NMC or have appropriate experience in the field



of the of the student they are supervising. They will have been nominated by the practice placement provider and they must be appropriately prepared for their role to meet the Nursing and Midwifery Council Standards for Student Supervision and Assessment (2018, updated 2023) to appropriately support and supervise a student. They must have undertaken a period of preceptorship in line with the NMC principles of preceptorship as a community nurse and can evidence prior learning and relevant practice supervisor experience that enables them to facilitate effective evidence-based learning opportunities for post-registration community nursing student.

Academic Assessor must hold an SPQ qualification with the NMC or have appropriate experience in the field of the of the student they are assessing. They will be nominated by the line manager and have been appropriately prepared for the role to meet the Nursing and Midwifery Council Standards for Student Supervision and Assessment (2018, updated 2023)

Practice supervisors and practice assessors must take account of students' individual learning needs and personal circumstances when allocating their practice learning including making reasonable adjustments for students with disabilities.

Practice supervisors or practice assessors cannot undertake the role of practice supervisor or practice assessor simultaneously for the same student.

For those students undertaking Nurse and Midwife Independent / Supplementary Prescribing module (V300), students will be required to meet the <u>Royal Pharmaceutical Society's Competency Framework for All Prescribers</u> (2022) and <u>NMC Standards for Prescribing Programmes (2018, updated 2023)</u> and <u>NMC Standards for student supervision and assessment (2018, updated 2023)</u>.

Each student will have a tripartite meeting between their Practice Supervisor, Practice Assessor and Academic Assessor to review progress towards meeting required proficiencies for their award at least once per semester. For those students undertaking the V300 this will also require the practice assessor for specialist community nursing and practice assessors V300 to meet and discuss student progress.

Students must be allocated protected learning time, as defined by the *Nursing and Midwifery Council Standards* for *Post registration Programmes* (2022). The level and amount of supervised protected learning time must be professionally judged by the Practice Assessor and will depend on the competence and confidence of the student and the risks associated with any intervention being delivered.

Within each practice placement, there will be a nominated person who has overall responsibility for the student's experience in practice and will support them and address any concerns regarding practice. This person may be the Education Lead or Line Manager.

Programme Structure

The programme structure and progression information below (Table 1a - 1h) is provided for the award. Interim awards are identified in Table 1g. The Programme Learning Outcomes detailed above are developed and assessed through the constituent modules. Table 2 identifies where each learning outcome is assessed.

Mode of study

For full-time students, the total number of credits undertaken per year will be 120 credits. For part-time students, the total number of credits undertaken per year will be 60 credits, meaning after two years, students will achieve 120 credits.

Entry point

There are two entry points to the programme, in Semester A and in Semester B to maximise flexibility for our practice partners.

- (Community Children's Nurse, District Nurse, General Practice Nurse) (NMC 2022), is mandatory for receipt of the annotation to the student's Nursing and Midwifery Council register.
- The module Practice Development in Community Nurse Specialist Practice, there can be no APCL or APEL awarded for prior learning as this is the practice component of the programme.
- Professional Practice requires the achievement of ALL Nursing and Midwifery Council (2022) standards of proficiency for community nursing specialist practitioners AND Nursing and Midwifery (2018, updated 2023) standards for prescribing programmes which are included within Practice Assessment Documents.
- 100% attendance is normally required in practice placement. Students who are unable to meet this requirement will need to undertake an additional period of learning in practice, negotiated with their practice supervisor, practice assessor and academic assessor.
- Research Project (7HSK2048) can only be undertaken on successful completion of Integrating Research with Contemporary Practice (7HSK2078) and Preparation for Research Project (7HSK2049) and can only be undertaken on successful completion of the Postgraduate Diploma Specialist Community Nursing Qualification.
- On completion of the programme, each student must submit a self-declaration of good health and character, as required by the NMC and which must be confirmed by the Programme Lead before the student can be recommended entry to the NMC as a Specialist Community Nurse: Community Children's Nurse, District Nurse, General Practice Nurse

G. Entry requirements

he normal entry requirements for the programme are:

- A UK degree, or other qualification at an equivalent level, in a health-related subject
- Current and active Nursing and Midwifery Council registration as a nurse (level 1) on the appropriate
 part of the register for Community Children's Nurses as a children's nurse; for District Nurses as an
 adult nurse and for General Practice Nurses normally as an adult nurse, although other routes will be
 assessed on application.
- Normally have a minimum of six months full time experience (or equivalent in part-time employment as a practising nurse) before being eligible to apply.
- Applicants must demonstrate safe and effective practice at the level of proficiency appropriate to the NMC-approved SPQ programme before being considered eligible to apply for entry. This is normally through check on work references, health to work assessments, DBS (enhanced disclosure) and successful interview.
- Access to an appropriate SPQ practice placement with a designated practice supervisor and practice assessor whilst enrolled on the programme. The specialist community practice placement is provided through the sponsoring employer and confirmed with the programme lead



- Normally students are sponsored by their employer to undertake the programme, however, it is possible
 for self-funded/ non-NHS/ self-employed students to enrol on the programme providing they are able to
 locate and negotiate an appropriate placement with a designated practice supervisor and practice
 assessor whilst enrolled on the programme, with an appropriate service provider e.g., NHS Community
 Trust or equivalent.
- Non-NHS, self-employed or self-funding applications must hold an SPQ honorary contract with their allocated sponsoring organisation commencing at the start of their programme, in addition to the University online application and supporting admissions form. Students are jointly interviewed with the supporting organisation and University.
- For commissioned students, successful interview with the sponsoring employer, conducted in collaboration with the University
- Evidence of a satisfactory DBS (enhanced disclosure) within the last three years
- Confirmation of competence to undertake the programme from the employer or supporting organisation for non-NHS, self-employed or self-funding
- For entry to the Nurse and Midwife Independent Prescribing module applicants must also complete a Supporting Admission Form (SAF):
 - Written confirmation of support to undertake the prescribing programme from their employer.
 - The support available must include time to attend scheduled study days at the University.
 - Access to appropriate learning opportunities in practice and protected time to engage in practice development activities with an identified practice supervisor and practice assessor.
 - Must also have a minimum of one year's experience (or equivalent in part-time employment as a practising nurse.

The programme is subject to the University's Principles, Policies and Regulations for the Admission of Students to Undergraduate and Taught Postgraduate Programmes (in <u>UPR SA03</u>), along with associated procedures. These will take account of University policy and guidelines for assessing accredited prior certificated learning (APCL) and accredited prior experiential learning (APEL).
