APPLICATION

Application is made via the Wozzad application portal https://www.applycpd.com/herts

Self-funding applications once submitted will move through to the CPD Team and will be referred for academic approval.

For those students that are funded by their **Trust/employer** the application must be approved <u>ONLINE</u> by an approver at the relevant organisation to enable the application to move through the system to be processed by the CPD Team.

FUNDING

Applicants who have applied for their fees to be paid by their sponsor should ensure their application is approved on the ONLINE APPLICATION SYSTEM by their Trust/employer otherwise it will **NOT** move through to the CPD Team to action.

Applicants should contact **cpdhealth@herts.ac.uk** if funding has been approved by their line manager or within their department but has not been approved on the online portal.

PROCESSING

The CPD Health team refer applicants for academic approval and complete fee assessment. Applicants that may not be eligible for Home Fees will be required to complete a Fee Assessment Form.

The CPD team ensure that applicants have provided all the necessary documents needed for the application and for registration. Once academic approval is given and all relevant checks complete, an applicant record is created on the student record system, an offer letter will be sent by email and the application status is updated in admissions, ready for the application record to move through to **preregistered** stage.

CREATE A LOGIN ACCOUNT

Within 40 days of the start of the course the approved applicant record moves to pre-registered on the Student Record System. Students that have not previously set up a UH login account will receive an email which will enable them to create a UH account.

Students must complete the set up of their login account so that the stage 1 registration email can be sent. A confirmation email is received once the login account is set up.

STAGE 1 REGISTRATION

The stage 1 registration email will go out 20 minutes after the login account confirmation email. Students should click on the link in the email to access their Student Record and complete stage 1 registration. This online part of the registration process should be completed on a PC but NOT an NHS computer. Students taking more than one individual module will need to complete stage 1 registration on <u>EACH</u> individual module course instance.

Once stage 1 registration is fully completed an email is received confirming **self-registered** status.

DOCUMENTS

CPD Health students MUST upload all required documents at the time of application onto the Wozzad application portal.

These are then managed by the CPD Team. Any missing documents will be requested by the CPD Team prior to the completion of registration.

STAGE 2 REGISTRATION

The Student Registry Team will complete student's final registration checks. Stage 2 registration for home students will be completed remotely. Students with an overseas fee status will be required to attend a face to face registration session.
