MSc Advanced Clinical Practice (Not for Degree Apprenticeship Route) Information for applicants and sponsoring health organisations

Introduction

This programme has been designed for registered healthcare professionals who wish to develop their competence in advanced drial practice, leadership, education and research as outlined in the Multiprofessional Framework for Advanced Clinical Practice in England (2017).

By the end of the course, learners are expected to

- Demonstrate a high level of autonomy in making required clinical decisions and act appropriately in complex and unpredictable situations.
- Undertake an advanced level of assessments, and through selection and interpretation of appropriate clinical investigations and results, formulate a diagnosis and a plan of care using personcentred approaches.
- Evaluate and initiate a range of evidencebased interventions, which may include for example prescribing of medicines, therapies and person-centred care.
- Lead service improvements, educate and develop others and provide consultancy services related to advanced practice within an individual's scope of practice.
- Critically evaluate the findings of research and audit to enhance advanced practice and service delivery, whilst developing a high level of expertise within one's own practice and that of others.

Entry criteria

Learners enrolling on the programme will need to demonstrate that they are able to meet the specified entry criteria:

- Normally a first degree in a health-related discipline. Applicants with evidence of equivalent professional development or academic proficiency will be considered.
- Current registration with one of the statutory regulators of health and care professions in the UK
- > Employment as a patient facing health care professional in an appropriate setting.
- Evidence of their employer's recommendation for their application for a programme of study leading to an Advanced Clinical Practice role including a formal reference from the employer confirming;
 - The applicant demonstrates professional values and behaviours, respecting people's diversity, beliefs, culture, needs, values and preferences and shows respect and empathy acting as a role model for others.
 - o The applicants 'clinical readiness' to undertake the programme.
 - Evidence of employer support to undertake the programme including the provision of appropriate clinical supervision.
- Normally a minimum of 3 years postqualification experience.

The employer is the named designated individual who represents the sponsoring health organisation and is responsible for the training and education in that organisation.

Support for learning and development in clinical practice

Learners enrolling on the programme require a wide range of supervised learning and development opportunities within clinical practice environments. The clinical time undertaken for these activities is evidenced as part of the coursework for most of the modules on the programme as illustrated in the table below.

It is therefore imperative that health organisations sponsoring leaners to undertake the programme can commit to providing a named Coordinating Educational supervisor who will supervise the learner throughout and

provide learning opportunities that will enable the learner to be successful in demonstrating the applied knowledge, understanding and skills that make up the aims of the programme.

The Coordinating Educational Supervisor must be a qualified Advanced Clinical Practitioner or medical practitioner within the clinical field of practice in which the learner will be developing as an advanced practitioner. This supervisor will provide ongoing guidance, mentoring and support throughout the programme. There are likely to be occasions when the lead supervisor is assessing the learner in practice. Learners will be given clear information regarding supervision and assessors for each of the modules.
